- 4) Examination fees shall be paid by the Institutions only through CHALLAN. Separate CHALLAN is to be obtained with respect to fees collected from students without fine and with fine. The Board will not accept D.D. or any other mode of payment.
- 5) Details of last examination appeared and verification of the same by the concerned College Principal should be submitted to the Board.
- 6) The applicant shall mention the year of passing the individual subject in the application form.
